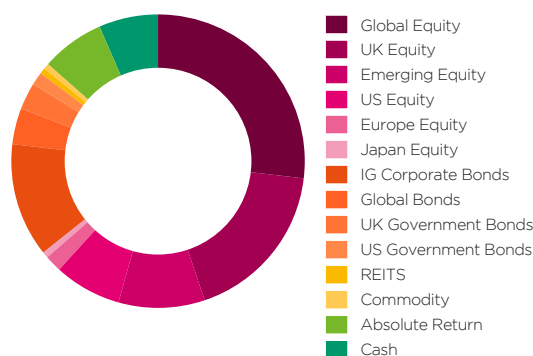

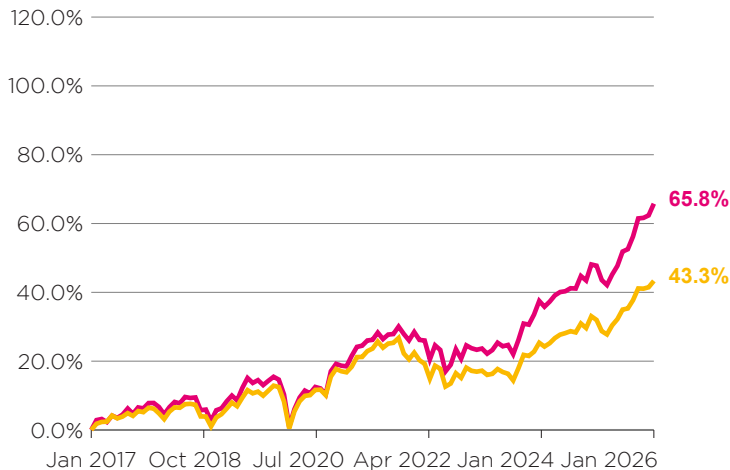

Pacific Balanced Portfolio GBP from 31 Jan 2017 to 30 Jan 2026

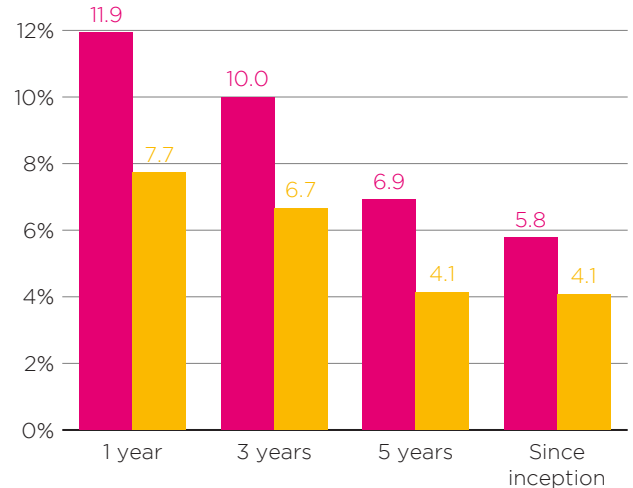
